

## KINSMEN MINOR SOCCER ASSOCIATION

### LEAGUE DISCIPLINE PROCEDURES

#### **1. First Level Discipline**

If you are delegated Head of Discipline for the 2007 Outdoor Season you are delegated the ability to conduct discipline for first level discipline only.

The following is a table of the misconducts which the leagues can issue discipline.  
Standard penalties for misconduct by a player.

1.6	Sixth Caution and any subsequent caution <b>DBR only</b>	3 Game Suspension	
1.13	Dismissed for receiving a second caution in the same game for which neither of the offenses was directed at the Game Official. (s) <b>DBR of DBH if requested</b>	1-Game Suspension	3 game Suspension
1.15	Dismissed for “using offensive, insulting, abusive language and/or gestures directed at anyone other than the game official.” <b>DBR or DBH if requested</b>	1 Game Suspension	3 Game Suspension
1.17	Dismissed for Denying an opponent a goal or an obvious goal scoring opportunity by deliberately handling the ball” <b>DBR or DBH is requested</b>	1 Game Suspension	2 Game Suspension
1.18	Dismissed for “Denying an opponent a goal or an obvious goal-scoring opportunity to an opponent moving towards the player’s goal by an offence punishable by a free kick or a penalty kick.” <b>DBR or DBH is requested</b>	2 Game Suspension	4 Game Suspension
1.19	Dismissed for Serious Foul Play <b>DBR or DBH if requested</b>	2 Game Suspension	4 Game Suspension

1.19A	Dismissed for Serious Foul Play where in the opinion of the Discipline Hearing Panel there was an obvious attempt to injure or a complete disregard for the safety of an opponent <b>DBH only</b>	4-8 Game Suspension	8-12 Game Suspension
1.20	Dismissed for spitting at an opponent or any other person other than the Game official <b>DBR or DBH if requested</b>	4 Game Suspension	8 Game Suspension
1.21	Dismissed for Violent Conduct DBR or DBH if requested	3 Game Suspension	6 Game Suspension
1.22	Received a third dismissal in a season	A discipline hearing shall be conducted and the appropriate discipline shall be rendered.	
<b>Standard Penalties for misconduct by a Coach or Administrator</b>			
2.31	Persisted in Misconduct after receiving a warning for misconduct from the game official for which neither of the offences was directed at the game official. <b>DBH only</b>	1 week suspension	3 week suspension
2.33	Used offensive, insulting or abusive language directed at anyone other than the Game Official. <b>DBH only</b>	2 week suspension	5 week suspension

All of the above misconducts can be dealt with by the Leagues and in accordance with the published rules of the OSA.

## **2. PROCEDURE ON HOW TO REQUEST A DISCIPLINE HEARING**

If you receive a Red Card the following will apply!

### **Requesting A Discipline Hearing**

If you are dismissed from a game within your league you have 2 days to contact your league to determine the reason for the dismissal and to submit a letter requesting a hearing. Note that the letter must be hand delivered or sent by Registered mail and must be accompanied by the \$50.00 request for hearing fee. If your league indicates that the dismissal was sent to the District the same rules apply you have 2 days to request a hearing in the same manner indicated above accompanied by the \$50.00 Request for hearing fee.

## **3. HOW DO DECISIONS BY REVIEW WORK?**

### **Decisions By Review**

If you refer to the Discipline Chart on Page 1 you will see that Decisions By Review occur for most of the Misconducts listed on this chart. If the Misconduct you have committed appears as being done by Review or has (DBR) beside it then you have the right to Request a Hearing please see above section on **Requesting a Discipline Hearing.**

If you choose to accept the penalty as indicated on the Discipline Chart on Page 1 then you are accepting the suspension or fine and your case will go to Decision By Review.

Decisions by Review are made by a three-person panel that will review the case and decide if the individual is guilty or not guilty. The Panel will advise the Club of the accused within two response days of the Decision By Review meeting of the outcome of the review. The League will indicate the specific games, which the accused is suspended.

Please note that the same rules apply for Decisions By Review done at the District Level. Note that you are not suspended unless you are notified by your league or the District that you are suspended.

#### **4. PROCEDURES ON HOW TO FILE A COMPLAINT**

##### Filing a Complaint

If you have a complaint, which you would like to file against a player, coach, referee, please forward the complaint to the league so that they are aware that you are filing a complaint. The league will then review the complaint and determine if it is within their ability to take action. The league may only take action if the complaint falls within the Discipline listed on the chart on page 1. The League must forward all referee complaints to the District. Please note that when filing a complaint if the League or District determines that a hearing is warranted then the author of the complaint will be required to attend the hearing. Should the author of the report refuse to attend a Discipline Hearing then the Hearing cannot take place.

#### **5. WHAT TO DO IF YOU ARE SUSPENDED?**

##### Suspensions

If you know that you are going to be suspended either by the District or the League you must wait until you are notified of the dates and timelines of your suspension before serving it. If you are going to be suspended for three games you must wait until the league or the District notifies you of the games, which you are going to be suspended from. You should not automatically assume that you are to sit out the next game, as it will not count towards your suspension unless you have been notified it is one of the games for which you are suspended.

Please note that the only exception to being automatically suspended is Game Official Assault. If you have committed Game official Assault you are automatically suspended from all soccer related activity and you would be contacted by your Club and the District notifying you of such.

Please note that if you are suspended from all soccer related activity you cannot participate in any soccer activities under the realm of the OSA. This includes administering, practicing, coaching, playing,

officiating, or any other activity related to soccer under the OSA guidelines.

Please note that when the District suspends you under the Decision By Review system you are charged an administrative fee of \$25.00 this must be paid in order to return to play after a suspension and the District Administrator prior to the suspension being served must stamp your book.
